# NAVAJO NATION HUNTING AND TRAPPING REGULATIONS

General Information


All Fish and Wildlife are the property of the Navajo Nation as a whole, All game, fish, and other wildlife, or the parts thereof, are protected on the Navajo Nation and may not be taken,

Possessed transported, or sold unless specifically permitted by these regulations. Hunting on the Navajo Nation is a privilege, the NN reserves the right to refuse hunting privileges to anyone.

#### What is Poaching?

is unlawfully

wildlife without

- The Navajo Reservation is stretched over 18 million acres consisting of 16 hunting units. Poaching occurs entirely over the reservation.
- ➤ We have 6 Wildlife Conservation officers patrolling these units, so it is very IMPORTANT to report every poaching activity within the Navajo Reservation boundaries to NN Fish & Wildlife and/or Officers.
- Poaching on the Navajo Nation of Mule deer, Elk, Bear, Mountain Lions, Golden Eagles and Wild turkeys.
- Poaching violations affect the hunting herd, funding and respectful hunting privileges, so therefore we are enforcing our Navajo Nation Laws for such violations.

# 7.04 Civil Liability; Illegal taking or Possession of Wildlife

> The Department of Fish and Wildlife may bring civil action against any person(s) unlawfully taking, wounding, killing, harassing, or unlawfully taking Possession of any of the following wildlife, or parts thereof, and seek to recover the

- following sums of restitution.
- B. All funds
  recovered shall be
  deposited into the
  Wildlife Theft
  Prevention Fund.




