## 2019 Special Hunt Application Wolf Springs Ranch

The Department of Fish & Wildlife, Colorado Ranch Enterprise received 30 cow elk applications from Colorado Parks & Wildlife. The 2019 Special Hunt Application is not a license and must be redeemed at a licensed agent for a proper and valid license. **This is an application to purchase a Colorado Parks and Wildlife Special Hunt for unit 861. All State License fees is Payable to: Colorado Parks & Wildlife.**

### General Information

- Application process is in accordance to the Colorado Parks & Wildlife Regulations.
- Applications will be a first-come, first-served basis. Priority is given to 10 Navajo youth hunters (12-17 years) whom did not draw a Navajo Nation hunting permit (1 application per family). **There is no Navajo Nation application or access fee.**
- Special Hunt Season: **November 1, 2019 to January 31, 2020.**
- Dates to hunt is selected by the hunter. Hunter(s) must notify the Department/Ranch on CO permit number and dates. A trespass permit will be prepared for hunter(s). No more than 3 hunters per selected hunt dates.
- Lodging is not available for this hunt, however if requested, arrangements must be made **a week** in advance for use of Lodging facility and cost is \$100.00. **Payable: Navajo Nation. Money Order Only.**
- Mandatory check in and out and submission of lower incisors at the Wolf Springs Ranch Office.
- There is also a mandatory submission of the Colorado Parks & Wildlife questionnaire for this hunt.

### Eligibility

- All hunters must meet the eligibility requirements established by the Colorado Parks & Wildlife hunting regulations. Applications are available at Department of FWL office and Wolf Springs Ranch Office.
- All Colorado Resident & Non-resident fees Apply. **Cow Elk:** Resident Adult=\$54.75, Resident Youth=\$15.50, Non-Resident Adult=\$496.75, Non-Resident Youth=\$101.50. A \$10.00 dollars Habitat Fee is also required.

### Application

- A 2019 Special hunt application must be completed and redeemed for a proper and valid license prior to hunting. This is an application to purchase a Colorado Parks & Wildlife Special Hunt.
- This is a Rifle hunt for **Antlerless Elk, Hunt Code: E-F-861-D2-R**
- Special Hunting Season (i.e. Game Damage) Harvest Survey Form must be submitted. Failure to do so is a violation of the commission regulation and may result in a citation being issued.
