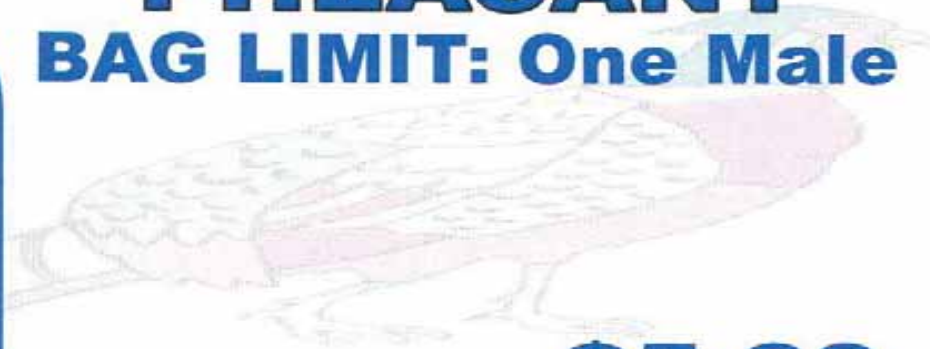

Molted eagle feathers are accumulated by the Navajo Nation and made available to Native Americans under permit MB054509-0.

Application for a permit to acquire an eagle feather requires certification that the requesting individual is an enrolled member of an Indian Tribe that is federally recognized under the Federally Recognized Tribal List Act of 1994, 25 USC 479a-1, 108 Stat.4791. Proof of tribal membership must be presented, and verified, to complete this application.

I hereby certify that I am requesting an eagle feather for religious purposes and that the information submitted herein is complete and accurate to the best of my knowledge. I understand that false statements made here may subject me to criminal penalties of 18 USC 1001. I hereby agree that I understand and will comply with all Navajo Nation and Federal Laws regarding eagles and eagle feathers.

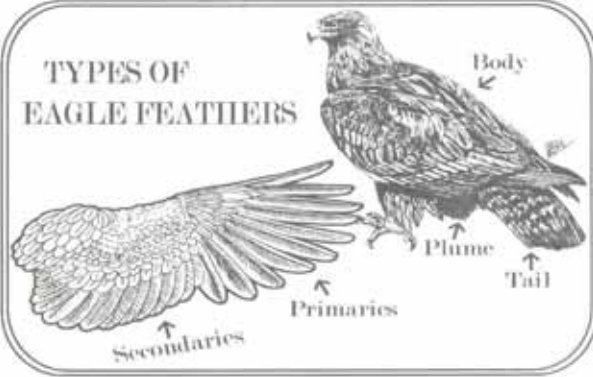

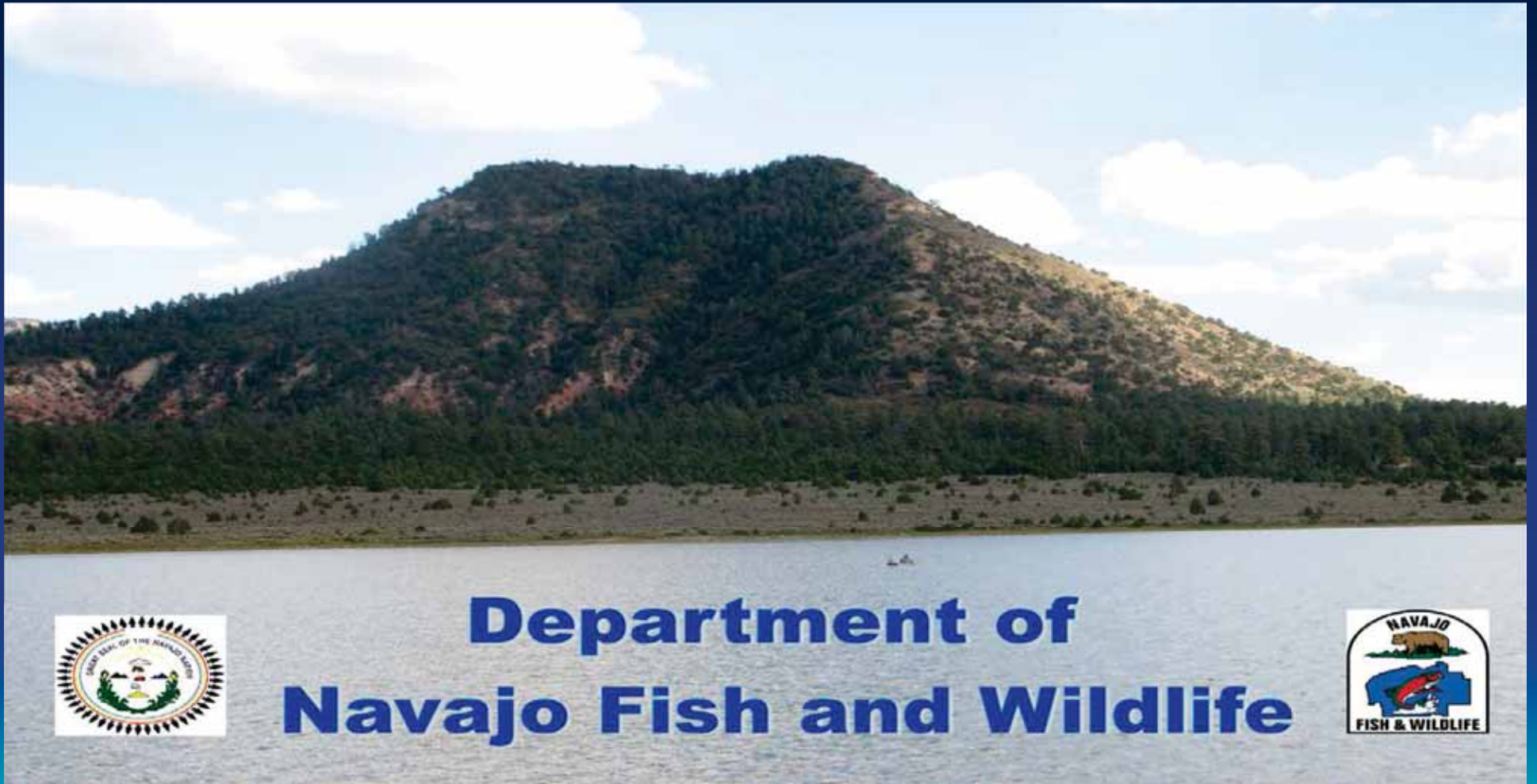
